- 1. Repair of Cryo-generator and restoration of Operation of old LN₂ Plant StirLIN-4.
- 2. The company must ensure steady production of LN_2 from the plant on completion of the job.
- 3. All the spare parts as required to restore the plant must be provided by the company.
- 4. Quotation should separately indicate the cost of non-consumable spares required and cost of service. No extra money will be given by NPL after purchase order is allotted.
- 5. Company should give in written to provide all necessary spare parts consumable and non-consumable in future (5 years) on payment basis as and when required to maintain the plant in good working condition.
- 6. All the special tools to dismantle and reassemble the plant (including the cryo-generator) will be provided by company.
- 7. Company must provide a Free Service Warranty of at least 6 months from the date of satisfactory completion of restoration of LN2 plant operation. There should be no limit towards the number of Emergency Breakdown visits / corrective maintenance visits during the warranty period. Such kind of Breakdown visits must be attended within 2-3 days.
- 8. Company must have experience of providing suitable service to at least 10 LN₂ plants through AMC or Repair Job Service in India. Bidder must have at least 2 AMC / Repair Service Orders from Govt. Sector /Semi Govt./Pvt. Sector in India during last 2 years. Such AMC / Repair Service Order copies must be furnished with the Offer.
- 9. No extra money will be given by NPL for boarding/Lodging and for journey (To & Fro). All the expenditure will be borne by the company. NPL wishes to provide lab guest house (dependent upon room availability) on chargeable basis.
- 10. Company must have their own dedicated service engineer's team on their payroll. Company should provide documents endorsing the existence of service engineers (at least three).
- 11. No advance payment request will be entertained. We can agree to release 90% payment within 30 days of the satisfactory operation of the LN_2 plant continues. Rest 10% will be kept as PBG and will be released after 6 months.
- 12. Companies are welcome to NPL for a look at the existing situation of nitrogen plant before quoting their offers. No extra charge will be taken from NPL for such visit.
- 13. Company must have at least one service engineer certified form our plant manufacturer. Copy of such certification must be enclosed with offer.
- 14. After six months warranty period, Annual Maintenance Cost (having two preventive services in regular interval and No limitation of emergency breakdown services any time during AMC) per year should be mentioned as optional.
