1. **PRICES:** Shall be quoted in Multi Currency including INR.
(A) For goods manufactured abroad:
 - (i) The price of the goods/services/calibration must be quoted on Ex-works/ DDP including taxes, if any.
 - ~~(ii) The charges for insurance and transportation of the goods to the port/place of destination if any.~~
 - (iii) The installation, commissioning and training charges including any incidental services, if any.
2. **VALIDITY OF OFFER:**
The Prices must be valid at least for a period of 90 days from the date of QUOTATION. No changes in prices will be acceptable in any condition after opening of tender till the validity of the offer or execution of the order whichever is later.
3. **REASONABILITY OF PRICES**
 - (a) Please quote best minimum prices applicable for a premiere Research Institution, **leaving no scope for any further negotiations on prices.**
4. **PERIOD & MODE OF DELIVERY:** The delivery period is the essence of supply; hence it must be indicated specifically in the quotation, period of calibration, delivery/completion time.
5. **PAYMENT CONDITION:**
