Important Note for MSEs / Start Up India / Make In India - DPIIT Policy Bidders

AND/ OR FAIL TO SUBMIT NECESSARY DOCUMENTS/ CERTIFICATES IN SUPPORT OF ITS CLAIM AT THE TIME OF BIDDING ITSELF, ITS CLAIM SHALL NOT BE ENTERTAINED AT A LATER STAGE IN THE BIDDING PROCESS AND NO OPPORTUNITY SHALL BE PROVIDED TO IT TO SUBMIT ANY DOCUMENT/ CERTIFICATE IN SUPPORT OF ITS CLAIM AS IT VIOLATES THE TENDERING PROCESS.
- Prospective bidders are advised to go through the original policy documents issued by concerned Ministry/ Department. However a brief overview of the main tendering related provisions of various policies is provided in Annexure VIII of this bid document.
